Re. Springfield Nursery Closure Proposal

Dear Parent or Carer,

As a parent or carer of a child who attends Springfield Primary School, we are writing to notify you of the proposal to permanently close the Nursery provision at the school by the 25th of July 2025. The proposal notice for you to read was sent to you on Friday 4th October 2024.

Springfield Primary School, its Governors, and Sheffield City Council will be holding a consultation on this proposal for a 6-week period from Friday 11th of October 2024 to Friday 22nd of November 2024.

The consultation will be undertaken using various methods to allow as many people from the community to respond with their views as possible. A "Have Your Say" Survey will be launched both online and paper based for families, people and partners in the community to respond. This Survey will be provided in many different languages to support the community's response. There will also be consultation sessions held in person and online throughout the consultation period to support people with completing the Survey, and/or to have more in-depth feedback discussions where required. In person consultation sessions will be held within the community at local venues such as Springfield Primary School and Sharrow Family Hub.

To ensure that you can have your say on this proposal, we will contact you again once the consultation is open with more information and how you can complete the survey and attend a session should you want to.

We hope that you will participate in the consultation once open, and if you have any comments, questions or queries on the consultation or matters relating to the consultation, you can let us know by contacting the school.

Appendix 1

PROPOSALS FOR THE CLOSURE OF THE NURSERY AT SPRINGFIELD PRIMARY SCHOOL

The proposer is the Governing Body of Springfield Primary School and Sheffield City Council Local Authority.

Springfield Primary School is a Local Authority maintained school with attached nursery, for children aged 3-11 years. The proposal is to permanently close the nursery attached to the school.

Implementation

It is proposed to permanently close the nursery by 25th July 2025.

Reason for Closure

There has been a reduction in the number of children taking up a place at the early year's nursery (3-4-year-old) provision at Springfield over the last 5 years, despite the best efforts of the school and its governors to improve this. The table below shows the numbers of children in the nursery from 2018/19 – 2022/23:

When the nursery was open, the school budget was running at a deficit due to the decreased uptake at the nursery. Therefore, if it reopened based on these numbers, it would continue to do so. This places pressure on the whole school budget. The impact on the school budget over the last 4 years in which it was open was a deficit of £50,112. The minimum number of children needed to make the nursery financially viable would be 34.

The school has had no choice but to subsidise nursery provision with Government funding (AWPU) allocated to other children across school from Reception to Year 6, which is having an impact on the quality of the provision that the school is able to offer to their primary pupils. Closing the nursery will allow the school to focus on meeting the complex needs of their Reception to Year 6 pupils with increasing SEND/EAL needs, by redirecting the financial resource back to where it should be used.

Springfield's 3 Year budget plan predicts a ~£582,338 total deficit, which along with declining nursery admission numbers, led to school governors reaching a decision to work towards permanent closure of the nursery.

Pupil Numbers and Admissions

The Springfield Primary School Nursery provided 52 places per year for children aged 3-5 years. Due to the school nursery currently being temporarily closed, it has 0 pupils (31st August 2024).

Displaced Pupils

This proposal will not cause displacement of any pupils. The Nursery has been closed temporarily since 1st September 2023 with no pupils in attendance.

Impact on the Community

Currently there are 39 nursery and PVI settings in the area delivering early years provision. There are surplus places across the area for 3 and 4-year-olds with a 93% take-up rate.

The number of good private provisions in the area who can offer greater flexibility in terms of age-range, opening hours and outside of term-time provision than the school nursery means that families would still have access to an Early Years place within their community for their children despite the closure of this nursery.

Through the temporary closure of the nursery, the building space is currently being used as a community hub to deliver various children and family health and social support sessions within the community. This provides a great community asset to use for community and family support in an area of high need and deprivation. Sessions being delivered include:

- Family and adult community education (family learning).
- Parent and toddler groups.
- Start Well programmes.
- Family Intervention Service and Family Hub programmes.
- Sheffield Children's NHS Services – child health workshops for continence, school nursing, and public health nurses.
- Afterschool club provision.

If the nursery was to close permanently following consultation, this space would continue to be used for the benefit of the children and community.

Travel

The locations of other nursery and PVI settings in the area are between 0.4 and 7 miles from Springfield Primary School. It is not anticipated that this proposal would result in an increased number of car journeys, due to other settings being within the same area of the city, and the nursery has been temporarily since 1st September 2023.

Consultation Responses: support; objections and comments
